1. Major Activities and Accomplishments during this Period -

The ONE LIT Team through host agency NEKCA has posted the Youth in Transition Facilitator position in February of 2010. After the first round of Interviews the position was posted again, NEKCA was able to hire the Youth in Transition Facilitator; Starting May 3rd.

ONE Youth in Transition Facilitator attended the Youth Voice Movement Conference on May 7th, 2010, with 3 youth from the area. YIT facilitators also attended their first ONE LIT meeting, on May 11, 2010 to formally meet the LIT team members. At this time the YIT Facilitator is in the beginning stages of learning about the services in the area and getting comfortable in the NEKCA Teen Center.
